

SECURITY MEMO

TO: THE GABLES ESTATES CLUB MEMBERSHIP

RE: NOTICE

YOUR SECURITY STAFF HAS ENCOUNTERED NUMEROUS SITUATIONS IN WHICH RESIDENTS HAVE ALLOWED NEWSPAPERS TO COLLECT ON RIGHTS OF WAYS OR IN FRONT LAWNS OF THEIR PROPERTY WHILE THEY WERE AWAY. IN MOST INCIDENTS, THIS HAS OCCURRED WITHOUT NOTICE BEING GIVEN TO OUR WACKENHUT STAFF FOR HOUSE CHECKS TO BE CONDUCTED DURING THE MEMBERS ABSENCE.

AS A SECURITY PRECAUTION, WE ARE PROPOSING TO ALLOW NO MORE THAN TWO (2) NEWSPAPERS TO ACCUMULATE BEFORE ACTION IS TAKEN TO REMOVE SAID NEWSPAPERS FROM THE RESIDENCE AND EITHER DISCARD THEM OR DISCREETLY PLACE THEM IN A NON-VISIBLE LOCATION WITHIN THE AFFECTED PROPERTY. THIS EFFORT IS BEING ADOPTED IN ORDER TO ENSURE THAT OPPORTUNISTS ARE NOT AWARE OF THE VACATED STATUS OF THE RESIDENCE. YOUR SECURITY COMMITTEE FEELS THIS APPROACH IS VITAL IN ORDER TO PROPERLY PROTECT OUR COMMUNITY FROM UNSAVORY CHARACTERS THAT MAY BE DRIVING THROUGH OUR STREETS SEEKING AN ADVANTAGE TO COMMIT CRIMES. WE DO NOT WISH TO ENCOURAGE THIS TYPE OF OPPORTUNIST AND WOULD GREATLY APPRECIATE YOUR COOPERATION IN THIS MATTER.

PLEASE NOTIFY CAPTAIN URRA AT 305-667-3284 OR 305-667-3604 TO REPORT YOUR PENDING ABSENCE. HE WILL ASCERTAIN THE NECESSARY INFORMATION FROM YOU TO BETTER SAFEGUARD YOUR HOME AND PROPERTY WHILE YOU ARE AWAY.

AS A REMINDER, WE ASK THAT YOU REPORT ANY SUSPICIOUS PERSONS OR VEHICLES TO OUR SECURITY PERSONNEL IMMEDIATELY. AS ALWAYS, YOUR COOPERATION IS GREATLY APPRECIATED. THANK YOU.
